ORDINANCE NO. 2016-33

AN ORDINANCE OF THE CITY OF FRESNO, CALIFORNIA, AMENDING SUBSECTION (d) OF SECTION 2-1105 OF THE FRESNO MUNICIPAL CODE, RELATING TO CAMPAIGN CONTRIBUTIONS.

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Subsection (d) of Section 2-1105 of the Fresno Municipal Code is amended to read:

(d) It is the finding of the City Council that an elected officer, candidate, committee or other person required to file statements, reports, or other documents described by Chapter 4 of the Government Code (commencing with Section 84100) ~~[who receives contributions or makes expenditures totaling more than \$1,000 in a calendar year]~~ shall file those statements, reports, or other documents online or electronically with the City. The City's online system can and will operate securely and effectively and will not unduly burden filers. By way of this finding, the use of online or electronic filing is hereby authorized and required for elected officers, candidates, committees and other persons filing statements, reports or other documents described in Chapter 4 of the Government Code.

SECTION 2. This ordinance shall become effective and in full force and effect at 12:01 a.m. on the thirty-first day after its final passage.
