A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE A GRANT AGREEMENT WITH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR THE CITY OF FRESNO'S BLACKSTONE AVENUE CORRIDOR SMART MOBILITY PROJECT

WHEREAS, the City of Fresno is eligible to receive State funding for certain transportation planning related to the Blackstone Avenue Corridor Smart Mobility Project, (Project) through the California Department of Transportation's Sustainable Communities Grant Program (Program); and

WHEREAS, pursuant to the Program, a Grant Agreement must be executed with the California Department of Transportation before such funds can be claimed; and

WHEREAS, the City of Fresno wishes to delegate authority to execute this agreement and any amendments thereto.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The above recitals are true and correct and incorporated herein.
2. The Council of the City of Fresno, California approves acceptance of the funding to the Project through the California Department of Transportation.
3. The City Manager or his designee is authorized to execute all reasonably required or implicated documents, instruments, and grant agreements related to the Project with the California Department of Transportation.
