



RESOLUTION NO. 2016-37

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR GRANT FUNDS FOR THE 2016 SYSTEMIC SAFETY ANALYSIS REPORT PROGRAM FROM THE CALIFORNIA DEPARTMENT OF TRANSPORTATION AND AUTHORIZING THE EXECUTION OF APPLICATION RELATED DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the Systemic Safety Analysis Report Program provides grant funds for eligible local agencies for the purposes of evaluating an entire roadway network using a defined set of criteria to identify high-risk roadway characteristics; and

WHEREAS, the California Department of Transportation administers the grant program and has requested applications from eligible agencies for their Cycle One Call for Applications; and

WHEREAS, the City of Fresno desires to ensure that its projects are delivered in a timely manner to preclude the Fresno Region from losing those funds for non-delivery; and

WHEREAS, it is understood by the City of Fresno that failure for not meeting project delivery dates for any phase of a project may jeopardize federal or state funding to the Fresno Region; and

WHEREAS, the City of Fresno demonstrates dedicated and available local matching funds;

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF FRESNO HEREBY:



SECTION 1. Agrees to ensure that all project delivery deadlines for all project phases will be met or exceeded;

SECTION 2. Directs the City Manager and the City Engineer to ensure that all projects are carried out in a timely manner as per the requirements of AB 1012 and the directive of the City Council; and

SECTION 3. Appoints and authorizes the Director of Public Works or designee, and each of them as agents for the City of Fresno, to execute and submit all grant application related documents, subject to prior approval as to form by the City Attorney's Office.
